<b>Terms &amp; Conditions T&amp;C14 (Teen地派)</b>
--

1. Teen 地派 service is only available to customer who has subscribed to the mobile telephone service of the Company ('Registered Customer').
2. The Registered Customer can subscribe up to a maximum of 2 Teen 地派 Plans for 2 Teen 地派 Users. Teen 地派 Users must be under the age of 18 at the time the Registered Customer subscribes the Teen 地派 service for him/ her. The Teen 地派 User must present his/her HKID card or other identify proof document at the time of application of the Teen 地派 service.
3. The Registered Customer is responsible for all matters relating to the Teen 地派 service including porting out, canceling, or activating the Teen 地派 services or reporting any lost SIM card.
4. The Registered Customer shall pay for all monthly and administration fees and other charges charged under the Teen 地派 service plan by auto direct debit and remote top up charged to his/ her account with the Company.
5. The Teen 地派 service account ('Teen 地派 Account') will only remain active if the Registered Customer's account remains active. In the event of suspension or termination of the service account of the Registered Customer, the Teen 地派 service and the mobile telephone services for the Teen 地派 User and any services under the Teen 地派 Account shall be simultaneously suspended or terminated with the suspension or termination of the service account of the Registered Customer.
6. If the service account of the Registered Customer is reconnected, the service to the Teen 地派 Account shall be reactivated on the next day after reconnection of the service account of the Registered Customer.
7. Upon termination of the Teen 地派 Account, any unused value, bonus, rebates, discounts and benefits (where applicable) under the Teen 地派 Account shall cease and be forfeited and would not be refunded to the Teen 地派 User and / or the Registered Customer or be transferred to another account.
8. The Registered Customer must subscribe to the Teen 地派 service for the fixed Contract Term as specified above. If the Teen 地派 service is terminated for whatever reason before the expiry of the Contract Term (as specified above), the Registered Customer shall pay the Company the liquidated damages specified above. If a Registered Customer subscribes to the Teen 地派 Account together with a special handset offer, the contract terms of such special handset offer shall prevail over the Contract Term.
9. The Teen 地派 service is only available to the Registered Customer and the Teen 地派 User until the Teen 地派 User reaches the age of 20. When the Teen 地派 User reaches the age of 20, he/she can continue using the mobile telephone service of the Company under the Teen 地派 mobile number provided he/she selects another service plan of the Company. If the Teen 地派 User fails to make the selection within 3 months after his/her 20<sup>th</sup> birthday, the Company reserves the right to convert the Teen 地派 service plan of the Teen 地派 User to any of the Company's service plan at the Company's discretion.
10. A music box will be provided to the Teen 地派 Users for use of the Teen 地派 service. The music box is the proprietary property of Music Box Company Limited and the Registered Customer and Teen 地派 User agree that Music Box Company Limited own all rights to the music box. In the event of suspension or termination of the Teen 地派 service, the service of the music box shall simultaneously be suspended or terminated for use with the suspension or termination of the Teen 地派 service.

**13. Applicable only to customers who are currently contract-bound by another operator and will port in his / her mobile telephone number to the Company's network on the Port In Date.**

- (a) In consideration of the condition stated in Clause 1 above, the Customer agrees to subscribe to the mobile telephone service of the Company and will port in his / her mobile telephone number to the Company's network on the Port In Date specified above. During the period from the date of this Agreement and the Port In Date ('Transitional Service Period'), the Company shall assign a Transitional mobile number to the Customer ('Transitional Mobile Number'). For the purpose of subscribing the Teen 地派 service, this Customer shall be deemed to be a Registered Customer (as described in Clause 1).
- (b) The Customer shall subscribe a HK\$0 Service Plan with HK\$18 Administration Fee for maintaining the account for the Transitional Mobile Number ('Transitional Account'). The Customer will not be able to use the Transitional Mobile Number for any telephony service but will receive SMS alerts from the Company in relation to the Teen 地派 service via the Mobile No. to be port in to the Company's network on the Port In Date specified above. The Customer acknowledges that he / she has to pay inter SMS charge when replying SMS to the Company for remote top up of the Teen 地派 service account.
- (c) The Customer agrees to pay the HK\$0 Service Plan with HK\$18 Administration Fee and any other charges under the Transitional Account by auto direct debit.
- (d) Upon the expiry of the Transitional Service Period, the Transitional Mobile Number and the HK\$18 plan shall automatically terminate and the Customer shall simultaneously select a \$128 3G Service Plan with the Company.
- (e) The Customer acknowledges that he / she has no right to the Transitional Mobile Number and cannot port out the Transitional Mobile Number to another network operator. The Company has the right to terminate, suspend or withdraw the Transitional Mobile Number if the Customer fails to pay any charges under the Transitional Account or the Teen 地派 service account is suspended or terminated for whatever reason.

**14. The Registered Customer and the Teen 地派 User(s) agree to the Video 風 Terms and Conditions (Video 風條款及條件).**
