1. Internet on Mobile (Plus) #^1:

- 1.1. \$28/month with 600MB⁺ (20MB*/ day) browsing usage.
- 1.2 Additional browsing and other data usage will be charged at \$15/15MB** (to the nearest 15MB); maximum thereafter data and other non-browsing data charge is \$298 per month.
- 1.3 300 local minutes for watching FoneTV channels (Chinese POP Hits, International POP Hits, and At the Movies).
- 1.4. Contract term for 15 months ('Term') is required.
- 1.5. The Customer shall pay SmarTone Mobile Communications Ltd liquidated damages (HK\$300) upon the occurrence of any of the following events before the expiry of the Term:
 - 1.5.1. if the customers terminates the Internet on Mobile (Plus)
 - 1.5.2. if the Customer changes the mobile telephone number / the registered name for the mobile telephone number; or
 - 1.5.3. if the mobile telephone service for the mobile telephone number is terminated/disconnected for whatever reason.

2. Internet on Mobile (Basic) #^{^123}:

2.1. When the Customer's browsing usage is over 20MB* per day, the service plan will automatically be upgraded from the Internet on Mobile (Basic) to the Internet on Mobile (\$78) with unlimited browsing. A SMS alert will be sent to the Customer's phone.

3. Internet on Mobile (\$78)#^12

3.1. Customer can enjoy unlimited browsing.

4. Internet on Mobile (\$108)#^12

- 4.1. Contract term for 12 months ('Term') is required.
- 4.2. Customer must subscribe to the Internet on Mobile (\$78), plus any 2 of the following 5 services:
 - 4.2.1. Mobile MSN or Internet Radio or RSS or Podcast or Mobile Email (POP3)
- 4.3. The customer shall pay SmarTone Mobile Communications Ltd liquidated damages (HK\$300) upon the occurrence of any of the following events before the expiry of the Term:
 - 4.3.1. if customers terminates the Internet on Mobile (\$108);
 - 4.3.2. if customers terminates any one of the 5 services specified in clause 4.2 within the Internet on Mobile (\$108)
 - 4.3.3. if the customer changes the mobile telephone number / the registered name for the mobile telephone number; or
 - 4.3.4. if the mobile telephone service for the mobile telephone number is terminated/disconnected for whatever reason.

2. Internet on Mobile (Plus)

Internet on Mobile (Plus) includes 600MB (20MB/day) browsing usage for: i) Browse Internet - via the native browser or the supported browsers* on your mobile phone**, ii) E-mailing - receive and send web e-mails via the native browser or the supported browsers* on your mobile phone**, download attachments/ files are not included; iii) View Internet video - stream Internet videos via the native browser or specific supported browsers* on your mobile phone**

* The usage via supported browsers is applicable to Internet on Mobile plans only if its user agent is set as default. The Internet on Mobile service fee does not include the cost of the browser software. Please refer to the browser providers' websites for detail information. 5. Podcast

Podcast for unlimited local Hong Kong streaming data usage (sent and received) but do not include uploading or downloading files, details as specified in the tariff plan.

The prohibited use and SmarTone-Vodafone action for any breach of prohibited use as specified above also apply to Podcast.

6. Internet Radio

Internet Radio for unlimited local Hong Kong streaming data usage (sent and received), details as specified in the tariff plan.

The prohibited use and SmarTone-Vodafone action for any breach of prohibited use as specified above also apply to Internet Radio.

7. Orb

Orb for unlimited local Hong Kong data usage (sent and received), details as specified in the tariff plan.

The prohibited use and SmarTone-Vodafone action for any breach of prohibited use as specified above also apply to Orb.


8. Mobile Email (POP3)

You must access POP3/IMAP4 pull emails via the pre-installed POP3/IMAP 4 applications on your mobile phone. Data usage doesn't include push emails.

The monthly fee covers local (HK) usage only. Standard data roaming charges apply whilst roaming.

You must use the service with settings (usage via the SmarTone-Vodafone APN) and devices specified by SmarTone-Vodafone. If you fail to do so, SmarTone-Vodafone has the right to forthwith suspend / terminate the Service.
