## 1) Service Plan and Offer Details:

1.1 The Customer shall use the Service Plan specified in the Sales and Services Agreement.

- 1.2 Contract free offer:
- 1.2.1 The Customer is not required to sign a fixed term contract if he prepays in advance 6 months of the monthly fees and administration fees specified in the Sales and Services Agreement.
- 1.2.2 The above prepayment will be credited back to the Customers' account ("Credit Amount") on a monthly basis over 6 consecutive months ("Term") commencing on the service commencement date.
- 1.2.3 This offer is available to specified monthly plan only.

## 2) Offer Terms and Conditions:

- 2.1 If, on the date of this Sales and Services Agreement, the Account is already subject to an arrangement (each a "Previous Credit Arrangement") under which any sums or charges prepaid by the Customer or the Company are to be credited by the Company to the Account, the crediting of the first installment to the Account by the Company under this Sales and Services Agreement shall be postponed to the date falling 30 days after the date of cessation of: (a) the Previous Credit Arrangement; or (b) if there is more than one Previous Credit Arrangements, the Previous Credit Arrangement with the latest expiry date. The date of cessation of the Previous Credit Arrangement with the latest expiry date. The date of cessation of the Account under the Previous Credit Arrangement is actually credited to the Account.
