## 1) Term:

1.1 The contract term for Duo Broadband Plan is 15 months ('Term') and starts from the service effective date.

## 2) Service Plan:

2.1 The Customer shall use the following applicable Service Plan as specified in the Sales and Services Agreement during the Term:

3.1 The Duo Broadband plan is only applicable to Customer who subscribes to specified 3G Integrated Data Combo. If Customer changes to other mobile service plan during the Term, the Customer is required to change this service plan to other applicable Duo Broadband for the remaining Term.
3.2 Fee covers local usage only. Local usage on smartphone does not include Blackberry E-mail usage, in which case $\$ 0.03 / \mathrm{KB}$ will be charged. $\$ 0.12 / \mathrm{KB}$ for roaming data access through SmarTone Wireless Smart Plug and its software from PC using mobile phone as a modem. Standard roaming data charges apply for Internet access on your PC without using our SmarTone Wireless Smart Plug and its installation software or the data access on your smartphone.

c) if the Customer changes the mobile telephone number / the registered name for the mobile telephone number; or
d) if the mobile telephone service is terminated/disconnected for whatever reason.
