## Terms & Conditions for Data Roaming Dollars (T&C - 1031)

The following terms and conditions are supplemental to the Sales and Services Agreement, the Company's Terms and Conditions for Mobile Telephone Service (please refer to T&C01 published at smartone.com), Terms & Conditions for Data Roaming Day Pass (please refer to T&C–I025 published at smartone.com) and Terms & Conditions for "Upgraded" Roaming Data Day Plan (please refer to T&C–I029 published at smartone.com).

- 1. Service Plan
- 1.1 The Customer shall use the following Service Plan as specified in the Sales and Services Agreement:

Data Roaming Dollars	НК\$36	Details of the relevant contract expiry date applicable to the Customer is stated in the Sales and Services Agreement or Supplemental Agreement to the Sales and Services Agreement.

- 1.2 The Service Plan is charged on a monthly basis. The monthly charges are payable in advance and nonrefundable under whatever circumstances.
- 2. Data Roaming Dollars
- 2.1 The Customer will be entitled to Data Roaming Dollars (worth HK\$1,000).
- 2.2 Data Roaming Dollars is only applicable to "Upgraded" Roaming Data Day Plan or Data Roaming Day Pass usage.
- 2.3 Daily rate of "Upgraded" Roaming Data Day Plan/ Data Roaming Day Pass will be deducted from Data Roaming Dollars in first use first serve basis.
- 2.4 If the Customer is entitled to other free roaming entitlements, the Data Roaming Dollars will be applied after the free entitlement(s) are used up.
- 2.5 Data Roaming Dollars are valid for 24 months from the date of activation. All remaining dollar will be voided upon expiry.
- 2.6 During the above validity period, the Customer is not entitled to other Data Roaming Dollars offer.
- 2.7 After all the Data Roaming Dollars is used up, subsequent roaming data usage will be charged according to the "Upgraded" Roaming Data Day Plan / Data Roaming Day Pass daily rate subscribed by the customer.



- 3. Liquidated Damages
- 3.1 The Customer shall pay the Company liquidated damages (which is HK\$36 x remaining months of the Term) upon the occurrence of any of the following events before the expiry of the Term:
  - a. if the Customer changes to a service not specified above; or
  - b. if the Customer terminates the Data Roaming Dollars; or
  - c. if the Customer changes the mobile telephone number or the registered name for the mobile telephone number; or
  - d. if the mobile telephone service is terminated or disconnected for whatever reason.
