1) Contract Term

- 1.1 The Customer shall use the SIM Only U Plan² service for the period specified in the Sales and Services Agreement ("Term"). The Term shall start from the service effective date.
- 1.2 Before contract expires, the Company's retention team will contact The Customer for the latest re-contract offer. Should the Customer decline offer, and upon expiry of existing contract, the Customer will automatically be switched to a then prevailing comparable plan on non-contract basis that is specified from time to time.

2) Service Plan Details:

- 2.1 The Customer shall use the Service Plan specified in the Sales and Services Agreement (or Supplemental Agreement to Sales and Services Agreement) during the Term.
- 2.2 Applicant must be aged 18 or above and a full-time student of designated post-secondary education institutions. For details of designated post-secondary education institutions, please refer to smartone.com/uplan/en.
- 2.3 Valid student ID card and HKID card / Passport must be presented upon registration for the Service Plan. Each HKID no. or Passport no. can only subscribe to the Service Plan once.
- 2.4 The Service Plan is charged on a monthly basis. The monthly charges for the first month will be charged on a pro-rata basis from the service effective date to the first bill date. The monthly charges are payable in advance and non-refundable under whatever circumstances.
- 2.5 This Service Plan is not applicable to 2G phones / connected devices or any phones / connected devices which have manually opted for 2G network, and not applicable to other connected devices (including but not limited to USB modem / pocket WiFi / TV box / BlackBerry smartphones with BlackBerry 7 OS and earlier versions).

- 2.6.2. Unused quotas of Customer Smartphone & Tablet Offer will be forfeited after the end of the Term.

- 2.8 The Credit Amount will be credited to the monthly bill of the Customer's Account. The first Credit Amount will be credited to the 1st monthly bill after the service effective date.

If the Customer does not follow this specification in the use of the Data Services, the Company has the right to forthwith suspend / terminate the Data Services without notice. Also the Company has the right to charge the Customer use of the Data Services at the Company's prevailing rate.
